# M&A Summary (1/3)

#### **M&A Summary**

The Carlyle Group acquires ManTech International (Herndon, VA) for \$4.2 billion. ManTech provides full-spectrum cyber, professional and technical solutions, and support services to U.S. defense, the IC and federal civilian agencies. With \$2.6 billion and \$268 million in Revenue and EBITDA, deal represents 1.6x and 15.7x multiples, respectively. Booz Allen Hamilton (NYSE: BAH) acquires Everwatch (Enlightenment Capital) (Reston, VA), a provider of advanced defense, intelligence, and deployed support to mission-critical federal government customers.

Vectrus (NYSE: VEC) and Vertex Aerospace (AE Industrial) merge creating a \$3.4 billion company with over \$280 million in EBITDA, roughly 14,000 employees and \$11.3 billion in backlog. The transaction value Vertex at 9.5x EBITDA or approximately \$2.1 billion. Combined company was renamed V2X and will be owned approximately 38% by Vectrus and 62% by Vertex. Two Six Technologies (Carlyle Group) acquires River Loop Security (Washington, DC), a provider of research and engineering services to deliver cybersecurity products and expertise to defense and commercial customers. Two Six also acquires Thresher Ventures (McLean, VA), which provides software that detects and analyzes media manipulation by foreign governments using AI, natural language processing and data science.

Parsons acquires Xator Corporation (Reston, VA) for \$343 million which includes the NPV of a \$57 million transaction-related tax benefit. This represents 10.7x estimated 2023 adjusted EBITDA. Xator provides critical infrastructure protection, counter-unmanned aircraft systems (cUAS), intelligence and cyber solutions, and global threat assessment and operations to the federal and critical infrastructure markets. Enlightenment Capital acquires Boecore (Colorado Springs, CO) which provides space, missile defense and aerospace technology to the federal government. Customers include Missile Defense Agency, U.S. Space Force and USAF. Enlightenment also forms another platform with the acquisition of PM Consulting Group (Towson, MD), a provider of management consulting and professional support services to agencies involved in international development and health care programs including USAID, DHA, DoD and civilian agencies.

Gunnison Consulting (Blue Delta Capital) acquires Centerpoint (Leesburg, VA), which provides cyber defense, response, and strategy as well as governance solutions for large enterprise data and services. This is Gunnison's 2nd acquisition (G2SF - Nov '20) since receiving an investment from Blue Delta. Federal Advisory Partners (Sagewind Capital) acquires Universal Consulting Services (Fairfax, VA), a provider of enterprise and health IT services including systems engineering and application development, system implementation, system integration, infrastructure and operations, and information assurance and security compliance.

Athenix (fka PCS-Mosaic) acquires 4 intelligence solutions companies (OSI, Agency Consulting Group, Kimmich, ExTech) from ASRC. ARSC acquires these assets as part of its Vistronix acquisition in 2016. The company will now have over 400 employees serving intelligence, cyber and special operations customers. The Acacia Group acquires The Baer Group (Atlanta, GA), a provider of digital transformation solutions in Enterprise Resource Planning (ERP), cloud integration, and data transformation to federal systems integrators and Fortune 500 clients. Supported platforms include Oracle, Salesforce, ServiceNow, AWS, Azure, and Google Cloud.

cBEYONData (Bluestone Investment) acquires Alta Via (Lenoir City, TN), a provider of consulting services for cost management, planning and simulation, business intelligence, and decision support. BigBear.ai (NYSE: BBAI) acquires ProModel (Allentown, PA), a provider of simulation-based predictive software used primarily in the manufacturing, healthcare, government, defense, and shipbuilding industries. Jacobs (NYSE:J) acquires Streetlight Data (San Francisco, CA) from various VC firms. Streetlight provides cloud-based analytics solutions to measure and manage transportation for companies and government sectors.

Saalex acquires Netsimco (Middletown, RI) for \$30 million. Netsimco provides warfare analysis, information technology, war game support, and advanced modeling and simulation to military and government customers and had 180 employees. Saalex indicates the deal will elevate revenue to \$100 million. ICF International acquires SemanticBits (Herndon, VA), a provider of health IT and data science solutions to government health agencies. DC Capital Partners makes a strategic investment in Valkyrie Enterprises (Virginia Beach, VA) and then merges it with Hill Technical. Valkyrie is a provider of maritime and defense engineering and technical services, including systems engineering, engineering design, training, and other services.

Sigma Defense (Sagewind Capital) acquires Sub U Systems (Turnersville, NJ), a provider of deployable tactical edge-of-network route, switch and computing technology solutions for intelligence, surveillance and reconnaissance markets. Markon Solutions, part of Anser Advisory, acquires integrateIT (Ashburn, VA) a provider information technology professional services and support to the defense and intel communities. ICV Partners makes investment in Beacon Global Strategies (BGS) (Washington, DC), a provider of strategic advisory services specializing in national security, defense and intelligence, cybersecurity, and homeland security.

EM Key Solutions acquires CORTEK from DecisionPoint Corporation. CORTEK, based in Fredericksburg, VA, provides systems engineering, software engineering, cyber support, and technical analysis to the Department of Defense, Department of State, and other government agencies.

Battle Investment Group acquires Bart & Associates (McLean, VA), a provider of modernization and transformation, integration and analytics, operations and enablement, and human capital management for federal customers including Agriculture, Defense, Health and Human Services, Homeland Security, Interior, and Justice. Daybreak and Azimuth merge. Azimuth1 (McLean, VA) provides data analytics, software development and geospatial analysis support to the FDA, NGA, and DHS. Brightstar Capital Partners merges two of its platform companies, ERC with Oasis Systems, creating a combined company focused on the aviation, space, defense, and cybersecurity markets.

DMI (Oceansound Partners) acquires Aurotech (OpenGate Capital) (Silver Spring, MD), a provider of full lifecycle modernization capabilities including application development, data science and analytics, cybersecurity, and digital strategy services. Tetra Tech (NASDAQ: TTEK) acquires Axiom Data Science (Anchorage, AK), which provides scalable solutions that help manage and conduct research within ecological, geological and ocean sciences. Applied Information Sciences (AIS) (Blue Delta Capital) acquires Xgility (Ashburn, VA), a provider of IT solutions in enterprise transformation using Microsoft technologies and platforms (Office, Sharepoint, Teams, Dynamics, and Azure).

Ignite Labs, along with Farragut Capital, through its SBIC Fund, acquired Atlas Executive Consulting (Charleston, SC), a provider of analytics, data science, and program support services to the national security sector. Definitive Logic (Blue Delta Capital) acquires Digital Mobilizations (Warrenton, VA), a provider of digital consulting solutions to federal and intelligence agencies. Torch.AI (Westcap Management) acquires B23 (McLean, VA), a provider of maritime autonomy and AI applications, including sourcing and aggregating mission data, such as geo-location, online analytics, and financial instrumentation.

M-Partners merges with Relavistic (Virginia Beach, VA), which provides cybersecurity solutions through deep learning and artificial intelligence defense clients. GCOM Software (Sagewind Capital) platform enters federal market with acquisition of ASR Analytics (Potomac, MD), a provider of business intelligence and analytic consulting services in the fields of business intelligence, predictive modeling, and data mining to higher education, government, and business markets. Unlimited Technology (Lee Equity) acquires Integrated Security Technologies (Herndon, VA), a provider of security management services to the government, healthcare, education and data markets. Deal enhances service offering and adds access and expertise in the federal sector.

**RSC2** acquires the **DoD** division of **TriMech Services**. The deal expands RSC2's systems engineering, modeling & simulation (M&S), acquisition support capabilities as well as a prime contract portfolio in support of defense and national security customers. **Mission Critical Partners (Egis Capital)** acquires **SecureHalo** (Silver Spring, MD), a provider of enterprise risk and cybersecurity solutions to federal, state, and local government agencies and commercial entities.

Castellum acquires Lexington Solutions Group (LSG) (Lexington, VA), a provider of planning and intelligence support for Information Warfare/Information Operations (IW/IO). Electrosoft Services acquires Achilles Shield (Vienna, VA), a provider of strategic cybersecurity, IT and strategic consulting services to government firms. Cerberus Cyber Sentinel acquires Creatrix (Columbia, MD), which provides systems architecture, software engineering, systems engineering, and systems integration with focus on biometrics, vetting, credentialing, and case management.

**Ad Hoc** acquires **Cascades Technologies** (Herndon, VA), a provider of data analytics and user experience solutions to government agencies. Primary customers include GSA and DOL. **Leonardo DRS** (Arlington, VA) merges with publicly traded **RADA Electronics Industries.** Combined company will contain a broad portfolio of defense products, including advanced sensing, force protection, network computing and electrical power, and propulsion.

**Apollo Information Systems** acquires **CyberDefenses** (Round Rock, TX), a provider of threat intelligence, incident response, election security and other cybersecurity services to U.S. federal, state and local government agencies and enterprises. **ClearShark** acquires **FedBiz IT Solutions** (Leesburg, VA), an enterprise solutions provider to the federal government. **SEMPRE.ai** acquires **NewSpace Networks** (San Jose, CA), a provider of terrestrial, maritime, airborne and space-based wireless communications solutions.
