QinetiQ acquires Avantus Federal from NewSpring Holdings for \$590 million. Avantus was formed in 2018 through the combination of E3 Federal and Sentinel followed by numerous bolt-on acquisitions (Data Works, Operational Intelligence, Lucid Perspectives, MissionTech Solutions, Occam's Razor Technologies (ORT). Avantus had 1,150 employees, 92% of whom were cleared. Avantus had \$298 million in revenue and \$35.5 million in EBITDA and is noted as 14.6x multiple, net of a \$70m tax asset. By Light Professional IT Services (Sagewind Capital) acquires Veraxx Engineering (Chantilly, VA), a provider of software defined radio and turnkey radio frequency ("RF") solutions for governments and enterprises.

Consulting Group (McLean, VA), a provider of Appian development and integration services to US federal agencies. This acquisition follows the initial acquisitions of Telesto Group (Dec21) and Collabralink (Jan22). The combined company has over \$100 million in revenue. SilverEdge (Godspeed Capital) acquires Qvine (Herndon, VA), a provider of agile software development, cloud services, and SaaS solutions to the IC. Qvine has over 100 employees, all of whom hold security clearances. SilverEdge also acquires Counter Threat Solutions (Reston, VA), a provider of all source and counterintelligence analysis, identity intelligence, and enterprise IT and data management solutions, including ServiceNow capabilities.

DMI (OceanSound Partners) acquires **Ambit Group** (Reston, VA), a provider of data management & analytics and cybersecurity services to the federal government including SEC, FEMA and CFPB. **Antarctica Capital** acquires **Descartes Labs** (Santa Fe, NM). Descartes Labs was spun off from the U.S. Energy Department's Los Alamos National Laboratory in 2014. **ECS Federal (ASGN Incorporated)** acquires **Iron Vine Security** (Washington, DC), a provider of cybersecurity solutions to federal clients including NIH, CMMS, SEC, and the Census Bureau. **Deltek** (NYSE: Roper Technologies) acquires **TIP Technologies** (Waukesha, WI) a provider o Provides quality management software (QMS) to customers in the aviation, space, defense, medical device, and complex manufacturing industries.

Boecore (Enlightenment Capital) acquires Ascension Engineering Group (Colorado Springs, CO), a provider of software and systems engineering, the DevSecOps software development practice, modeling and simulation, and systems integration and testing. Leidos acquires Cobham Aviation Services Australia's Special Mission business, which provides airborne border surveillance and search and rescue services to the Australian federal government, for \$212 million.

Enlightenment Capital acquires iNovex (Columbia, MD) a provider of software development platforms focused on signals intelligence, cybersecurity, robotic process automation and data analysis for federal government, intelligence community and commercial clients. LMI (Declaration Partners, Capitol Meridian, 22C Capital) acquires Synaptech (Colorado Springs, CO), a provider of digital engineering, modeling and simulation software for the national security and space industries. Janus Research (CM Equity) acquires Cape Henry Associates (Virginia Beach, VA), a provider of manpower and personnel analyses and training solutions for the Department of Defense and other Federal customers.

IBM acquires Octo (Reston, VA), from Arlington Capital. Octo provides artificial intelligence, cloud and infrastructure, DevSecOPs, data management and analytics, and cybersecurity solutions to the US federal government, including its defense, health, and civilian agencies. Arlington acquired Octo in 2019. Cydecor acquires InnovaSystems International (San Diego, CA), a provider of agile software development, data management, data analytics, onsite training, technical and engineering expertise for federal, state and local government agencies. OceanSound Partners acquires Gannett Fleming (Camp Hill, PA), a provider of engineering and infrastructure consulting firm that works with government agencies and customers in certain commercial verticals.

DLH Holdings acquires **Grove Resource Solutions (GRSi)** (Bethesda, MD), for \$184 million. GRSi provides IT infrastructure modernization and architecture design, software engineering, technology assessment and insertion, and multi-tier IT service management to government clients including NIH, Navy and Marine Corps. Deal adds 700 employees, \$140 million in revenue and \$550 million in backlog and expands enterprise modernization and cybersecurity offerings. **The Sanborn Map Company** acquires **AppGeo** (Boston, MA) a provider of geographic information software system technologies and services designed to create location intelligence as well as GIS consulting services.

Kratos Defense & Security acquires the Engineering Division of Southern Research for \$80 million. The division provides development, modeling and deployment of advanced materials for extreme environments, including hypersonic, space, missile, missile defense, strategic deterrence, propulsion systems, and energy applications. Approximately 1/4 of purchase price was for SRE's 54-acre campus with a 102k sq. ft lab. Madison Dearborn acquires a majority stake in Unison Global from Carlyle Group. Unison provides software used by federal agencies and government contractors to keep track of projects, procurements and supply chain functions. Carlyle acquired Unison originally in 2005, sold it to Abry in 2010 and then re-acquired it in 2020.

Declaration Partners, Capitol Meridian and 22C Capital acquire LMI's for-profit subsidiary. The remaining entity will rebrand as NobleReach Foundation. The acquired entity provides digital services, advanced analytics, logistics and management advisory services across the federal government. CNSI (The Carlyle Group) acquires Kepro (Nashville, TN) from Apax Partners. Kepro develops care management and clinical assessment technology. VTG (The Jordan Company) acquires Next Rev Technologies (Upper Marlboro, MD), a provider of cloud computing, data science and advanced analytics solutions to federal customers.

Enlightenment Capital acquires PrintScan (Hicksville, NY), which provides fingerprinting and background screening, professional live scan and ink fingerprinting services, face scan, signature pads, and other services to public and private sector clients. Enlightenment Capital also makes a strategic investment in Laxton Group (San Antonio, TX) a provider of Provides fingerprinting and background screening, professional live scan and ink fingerprinting services, face scan, signature pads, and other services to public and private sector clients. Deep Water Point (Renovus Capital) acquires Wolf Den Associates (McLean, VA), which provides capture and proposal, strategy, management consulting and transaction advisory support services in the federal market.






