

Introduction: Technology Services Strategic Dashboard

M&A volume in the Technology Services sector decreased 15% in Q4'22, relative to Q3'22, returning to similar levels seen in Q4'21. Share price performance in the Technology Services sector showed modest recovery in Q4'22. Public market valuation multiples have compressed, declining 22.1% in Q4'22 vs. Q4'21.





Managed Services - Sector Breakdown













Key Managed Services Publicly-Traded Comparables

Revenue growth and EBITDA margins drive valuation multiples in the Managed Services space. The median EV / 2023E EBITDA multiples are 10.9x and 15.4x, for Managed Services and Managed Infrastructure, respectively.



2022E EBITDA Margin %















Share Price Performance by Technology Services Sub-sector




2021 - 2022 EV / LTM Revenue Performance

2021 - 2022 EV / LTM EBITDA Performance


